Dr. Smith noted that discussions will occur at the Council of Graduate Schools (CGS) in November, so opinions from the Purdue community will be important. Questions to consider:

1) What are the global and local trends in doctoral education? 2) What are growth trends in fields or degree types? (i.e.: What is happening with the professional or clinical doctorates and how will these fit in with the work force?) 3) What are the similarities and differences between doctorates and professional doctorates?
