Purdue Athletics requests approval to name the Ross-Ade Stadium football field "Rohrman Field." In 1924, Ross-Ade Stadium was constructed and named in honor of David E. Ross and George Ade, its two principal benefactors. Today, Purdue Athletics looks to transform Ross-Ade Stadium both programmatically and structurally to support high-level success for the future. This initiative will have a broad university and community impact – it's far more than a football project. It is an important next step in strengthening Purdue's national prominence.

This request honors the generosity of the Bob Rohrman family in the amount of \$15 million. The gift will be used to support the future of Ross-Ade Stadium, which will create lasting memories for countless Boilermakers. The Rohrman family owns and operates one of the largest auto groups in the United States, and it began in Lafayette, Indiana. Currently, the family owns 30 franchise dealerships throughout the Midwest. This is the family's first transformational gift to Purdue Athletics.

I believe naming the Ross-Ade Stadium football field is an appropriate recognition of the Rohrman's generosity and support of Purdue Intercollegiate Athletics, and I request your approval for the naming of the "Rohrman Field" at Ross-Ade Stadium.
