Upon discussions with Patty Jischke, we would like request to transfer the honorary name for the <i>Patty Jischke Early Care & Education Center</i> .		
The Patty Jischke Early Care & Education Center is currently located at 90 Nimitz Drive, West Lafayette, IN 47907 and slated for demolition as part of the Discovery Park District development. Given the plans for demolition, we would like to transfer the Patty Jischke Early Care & Education Center name to a new childcare facility that will be located adjacent to 2550 Northwestern Avenue in West Lafayette. The new childcare construction project was approved by the Purdue Board of Trustees in December 2019 and is scheduled to be completed in December 2020.		
As a member of the Purdue Naming Committee, I recommend we move this naming opportunity forward to the president for Board approval. I respectfully request your endorsement to transfer the honorary name of the <i>Patty Jischke Early Care & Education Center</i> to the new location.

Exhibit A: Child Care Facility Location

Project Description:

- This project includes the construction of a new, approximately 16,600 GSF child care facility on the two acre parcel adjacent to 2550 Northwestern Avenue in West Lafayette. The facility will be owned by Purdue and operated by a third-party vendor.
- The new facility will serve approximately 150 children with rooms specific to infants, toddlers, and preschoolers. Each room includes meal preparation areas and bathrooms.
- Project delivery method: Construction Manager as Constructor
- Guaranteed Maximum Price delivery: April 2020
- Construction start: June 2020
- Construction completion: December 2020

Project Benefits:

- The new child care facility will provide additional capacity to help offset the closure of the Patty Jischke Early Care and Education Center, which will be demolished as part of the Discovery Park District development.
- The consolidation and revision of the University's operating agreement with a selected child care provider will generate revenue, including lease payments, to help offset the cost to construct the facility.

Resolution Concerning

Child Care Facility

Resolved, By The Board of Trustees of The Trustees of Purdue University (the "Corporation"), as follows:

- 1. The Board hereby finds that a necessity exists for the planning, financing and construction as well as for the awarding of one or more contracts for the completion of the project identified as "Child Care Facility" at the Purdue University West Lafayette Campus (the "Project"), the location of which is shown in Exhibit A.
- 2. In order to provide funds with which to accomplish this project, the Treasurer of The Trustees of Purdue University is hereby authorized to use Operating Funds-Reserve in the amount of \$6,900,000 (the "Authorized Cost Level").
- 3. For purposes of Article VII, Section 1(c) of the Bylaws, no change orders in connection with any of the above-referenced contracts shall require further Board or Committee authorization and approval unless and until such a change order, together with all other change orders previously authorized, approved and executed by the Treasurer, causes the aggregate amount of expenditures incurred under such contracts to exceed the Authorized Cost Level for this project (it being understood that any change order or any other action that would cause such Authorized Cost Level to be exceeded must, before it is given effect, receive the express prior approval of the Committee and the Board).
- 4. The Board authorizes and directs the Treasurer of The Trustees of Purdue University to select, retain and contract with an architectural/engineering firm to provide planning services for such amount and on such terms as he in his sole discretion shall deem to be in the best interest of Purdue University.
- 5. The Treasurer of the Corporation be, and hereby is, further authorized and empowered to delegate to one or more officers and representatives of the Corporation or of Purdue University such tasks and responsibilities with respect to the completion of the Project as he, in his sole discretion, shall deem to be in the best interests of the Corporation and Purdue University and consistent with the exercise of the authority granted above.
- 6. The Chairman, Vice Chairman, Treasurer, Assistant Treasurer, Legal Counsel, Assistant Legal Counsel, Secretary and Assistant Secretary of the Corporation, and the Treasurer and Chief Financial Officer and the Senior Vice President and Assistant Treasurer of Purdue University, and each of said officers respectively, are hereby authorized and empowered for, on behalf and in the name of the Corporation, or of Purdue University, to: (a) request the necessary approvals of the Governor and the Budget Agency and all other necessary governmental approvals for the actions hereinabove authorized; and (b) take all other necessary and proper actions to carry out the purpose and intent of this Resolution, whether herein specifically authorized or not, except such actions as are specifically required by law to be taken by the Board of Trustees as the governing board of the Corporation.






EXHIBIT A: CHILD CARE FACILITY LOCATION
