Re: Approval of 2021-2023 Budget for the Animal Disease and Diagnostic Lab

The Indiana Animal Disease Diagnostic Laboratory (ADDL) at Purdue University aids in the prevention, control, and eradication of animal diseases for the State of Indiana and provides prompt and accurate diagnostic services as the only veterinary diagnostic laboratory in the state. The ADDL provides these critical services on behalf of the State Board of Animal Health.

We are recommending an increase to the current \$3.7 million ADDL appropriation as follows:

- Avian Pathologist \$142,000 (recurring). Adds one pathologist at the Heeke laboratory to address growing demand.
- Biosafety Cabinet (BSC) and filter replacement \$50,000 (non-recurring for 2 years); \$6,334 (recurring). Replacement of 10 biosafety cabinets and 19 BSCs filters for the safety and protection of ADDL employees and students and prevention of sample cross contamination.
- Incinerator Equipment \$25,000 (non-recurring). Replacement of the West Lafayette incinerator to ensure proper performance and accept whole large animals.
- Salary and Fringes \$126,933 (FY 2022 recurring); \$141,087 (FY 2023 recurring). 3.0% annual increase in salaries and 5.0% annual increase in fringe benefits to retain trained and experienced personnel.
