

## Schleman Hall, Stewart Center and Related Renovations

#### Scope

- Renovate 101,000 GSF in Schleman Hall for the Data Science program
  - Includes teaching labs, group workspaces, study space and offices
- Renovate 45,000 GSF of Stewart Center and 10,400 GSF in the Purdue Memorial Union, Hicks Undergraduate Library and Recitation Building
  - Modernizes student services and accommodates new occupants






## Schleman Hall Renovation for Data Science

#### **Project Goals and Benefits**

- Early implementation of Future of Work concepts
- Renovate rather than build new more efficiently using space and avoiding increased operating costs
- Locates Data Science convenient to other College of Science facilities
- Active, connected collaboration spaces
- More open environments, and strategically located collaboration spaces
- Decrease private offices, both amount and size and increase hoteling space







## Stewart Center and Related Renovations for Student Services

#### **Project Goals and Benefits**

- Early implementation of Future of Work concepts
- Co-locates student services in STEW optimizing current and prospective student experiences
- 60% increase in student-facing space
- Provides proper theater(s) for Admissions presentations
- Waiting/meeting space used as study/collaboration space after hours
- More efficient space use, increasing the building density within renovated areas from 200 to 570 headcount

Student-facing functions line the corridor while office functions remain backstage







## Schleman Hall, Stewart Center and Related Renovations

#### **Project Status**

- Design is almost complete
- Current tenants in STEW have moved to temporary space
  - Meeting space in STEW and PMU expanded
  - Storage in University Church and 2550 Northwestern Ave.
- Construction schedule:
  - Start: April 1, 2022
  - Complete: April 28, 2024
  - Occupancy: Aug. 1, 2024



## Upcoming Future of Work Opportunity

### Goal: Renovate instead of building new or leasing

- Potential to move up to 1.7M volumes to an offcampus book repository
- Reclaim up to 18,000 SF of prime, central campus space that could be repurposed for a mix of library, classroom or academic uses
- Leverage currently underway master planning efforts for Libraries and Classrooms to guide future decision making
