Re: Proposed Amendments to Employment Agreement – Coach Katie Gearlds

Date: June 1, 2024

Under general guidance from the Compensation Committee, Director Bobinski has once again advanced discussions with Coach Gearlds agent and reached agreement on amended contract terms for her. A brief summary of the key terms is attached, and it will be used to create an official First Amendment to the Employment Agreement as promptly as practicable.

Highlights of the proposed changes include:

- Extension of current term of agreement by two years, to June 30, 2029.
- Increase in base salary to \$700,000 (from current \$550,000).
- Continuation of scheduled \$20,000 annual increases, but with a good faith commitment by Purdue to consider additional increases based on program performance and athletic department financial capacity and circumstances.
- Adjust schedules of buyout payments for both a termination by Purdue without cause scenario and a termination by Coach Gearlds if she elects to leave early.

Consistent with past practice, we will request Compensation Committee and full Board approval of these proposed amendments at the upcoming stated meeting, together with a grant of delegated authority to the President, the Athletic Director and the Chair of the Compensation Committee to approve, execute and deliver the definitive form and final terms of the contract amendment (consistent with the attached summary).

Your approval of the proposed terms is respectfully requested.
