#### **Project Description:**

- Competitive bids have been received for this project. However, the prevailing market conditions reflect that to ensure successful completion of the project scope, the estimated total cost of this project has increased from \$11,800,000 to \$12,750,000.
- A combination of Gift Funds and Auxiliary Funds Other will allow for the completion of the Purdue Airport Terminal as presented on August 4, 2023 and summarized below.
   Specifically, these funds will ensure the completion of the parking lot and railroad track pedestrian crossing.
- This project will construct a new, approximately 10,000 gross square foot terminal west of the existing terminal to include restrooms, waiting area, baggage claim, ticketing and passenger screening.
- The new terminal will be constructed to comply with Transportation Security Administration (TSA) and Federal Aviation Administration (FAA) requirements.
- Existing airport hangar T-1 will be demolished, and new, short-term parking will be added in its place. Safety improvements will be made to the railroad track pedestrian crossing.
- Project delivery method: Construction Manager as Constructor
- Guaranteed Maximum Price delivery: March 2024
- Construction start: May 2024
- Construction completion: September 2025 (Previously May 2025)

# RESOLUTION OF THE BOARD OF TRUSTEES OF THE TRUSTEES OF PURDUE UNIVERSITY INCREASING THE AUTHORIZED COST LEVEL FOR PURDUE AIRPORT TERMINAL

**WHEREAS**, by a resolution adopted on August 4, 2023 (the "Prior Resolution"), the Board of Trustees (the "Board") of the Trustees of Purdue University (the "Corporation") authorized and approved the Purdue Airport Terminal at the Purdue University West Lafayette Campus (the "Project"); and

**WHEREAS**, the Prior Resolution granted the Treasurer the authority to advance the Project for a total Authorized Cost Level of \$11,800,000 (the "Authorized Cost Level"); and

WHEREAS, the Board has determined that the Project Authorized Cost Level should be increased in order to accommodate additional costs considerations prompted by prevailing market conditions and to ensure the successful completion of the Project;

#### **NOW, THEREFORE, BE IT RESOLVED**, by the Board as follows:

- 1. The Board hereby finds that a necessity exists to increase the Project's Authorized Cost Level from the previously authorized \$11,800,000 to \$12,750,000.
- 2. In order to provide funds with which to accomplish the Project, the Treasurer is hereby authorized to use \$12,639,148 in Gift Funds and \$110,852 in Auxiliary Funds Other.
- 3. The Chairman, Vice-Chairman, Treasurer, Assistant Treasurer, General Counsel, Deputy General Counsel, Secretary and Assistant Secretary of the Corporation, and the Treasurer and Chief Financial Officer and the Senior Vice President and Assistant Treasurer of Purdue University, and each of said officers respectively, are hereby authorized and empowered for, on behalf and in the name of the Corporation, or of Purdue University, to take all necessary and proper actions to carry out the purpose and intent of this Resolution whether herein specifically authorized or not, except such actions as are specifically required by law to be taken by the Board as the governing board of The Trustees of Purdue University.



# **Resolution Concerning Purdue Airport Terminal**

**Resolved**, By The Board of Trustees (the "Board") of The Trustees of Purdue University (the "Corporation"), as follows:

- 1. The Board hereby finds that a necessity exists for the planning, financing and construction as well as for the awarding of one or more contracts for the completion of the project identified as "Purdue Airport Terminal" at the Purdue University West Lafayette Campus (the "Project").
- 2. In order to provide funds with which to accomplish this Project, the Treasurer of the Corporation is hereby authorized to use State funds in the amount of \$7,000,000, Gift Funds in the amount of \$3,300,000 and Federal Grant in the amount of \$1,500,000 for a total of \$11,800,000 (the "Authorized Cost Level").
- 3. For purposes of Article VII, Section 1(c) of the Bylaws, no change orders in connection with any of the above-referenced contracts shall require further Board or the Board's Physical Facilities Committee (the "Committee") authorization and approval unless and until such a change order, together with all other change orders previously authorized, approved and executed by the Treasurer, causes the aggregate amount of expenditures incurred under such contracts to exceed the Authorized Cost Level for this project (it being understood that any change order or any other action that would cause such Authorized Cost Level to be exceeded must, before it is given effect, receive the express prior approval of the Committee and the Board).
- 4. The Board authorizes and directs the Treasurer of the Corporation to select, retain and contract with an architectural/engineering firm to provide planning services for such amount and on such terms as he in his sole discretion shall deem to be in the best interest of Purdue University.
- 5. The Treasurer of the Corporation be, and hereby is, further authorized and empowered to delegate to one or more officers and representatives of the Corporation or of Purdue University such tasks and responsibilities with respect to the completion of the Project as he, in his sole discretion, shall deem to be in the best interests of the Corporation and Purdue University and consistent with the exercise of the authority granted above.
- 6. The Chairman, Vice Chairman, Treasurer, Assistant Treasurer, General Counsel, Deputy General Counsel, Secretary and Assistant Secretary of the Corporation, and the Treasurer and Chief Financial Officer and the Vice President and Assistant Treasurer of Purdue University, and each of said officers respectively, are hereby authorized and empowered for, on behalf and in the name of the Corporation, or of Purdue University, to: (a) request the necessary approvals of the Governor and the Budget Agency and all other necessary governmental approvals for the actions hereinabove authorized; and (b) take all other necessary and proper actions to carry out the purpose and intent of this Resolution, whether herein specifically authorized or not, except such actions as are specifically required by law to be taken by the Board as the governing board of the Corporation.
