I write to ask for your approval to appoint Dr. Kam Fung (Kevin) So, Professor of Hospitality and Tourism Management here at Purdue, as the C.B. Smith Endowed Professor of Hospitality and Tourism Management. Dr. So was recruited to Purdue this Fall 2024 under the movable dream hire program. The C.B. Smith Endowed Professorship at Purdue was created "... to attract and retain a professor with an international reputation" in the HTM department. While not detailed in the endowment agreement, for the purposes of selection, the C.B. Smith Endowed Professorship will be given to a professor who has an international reputation as a leading scholar in the field, an established and sustained record of publication in top tier hospitality and tourism journals, as well as an exemplary record in graduate student mentorship. In addition to significant achievements in learning, discovery and engagement, the C.B. Smith Endowed Professor will elevate the academic standing and reputation of the White Lodging-J.W. Marriott Jr. School of Hospitality and Tourism Management. As outlined in the recommendation from representatives of the Primary Committee of the school, which served as the review team for this nomination, Dr. So reflects these considerations in abundance.

His significant academic contributions were recognized at his former institution, Oklahoma State University, where he was the William S. Spears Chair (endowed) in Business. Further, the accompanying letters of support from leaders in the field who, having reviewed Dr. So's work, are enthusiastic about his contributions also. Purdue University recently recognized his accomplishments and his promise by recruiting Dr. So as part of the strategic movable dream hire

initiative. Taken together, Dr. So exemplifies the characteristics of the C.B. Smith Endowed Professorship. We thank you for your consideration of his appointment to this prestigious position.
