RE: FY 2026 and FY2027 Tuition and Fee Schedule

The FY 2026 and 2027 Student Tuition and Fee Schedule will be presented for your approval at the June Board of Trustees meeting.

As a reminder, State statute requires that Purdue determine its student tuition and fee rates for a two-year period shortly after finalization of the state biennial budget. The Indiana Commission for Higher Education, also pursuant to state statute, sets a non-binding recommended fee increase for Indiana resident undergraduate students enrolled at state educational institutions prior to the institutions finalizing their rates. The Commission's recommendation for FY 2026 and 2027 is that there be no increase to tuition and mandatory fees (defined as any fee paid by all enrolled students).

The detailed schedule of proposed fees at all three campuses is attached for your reference. As has been previously announced publicly, the schedule includes a continuation of the freeze on tuition and mandatory fees for the Main Campus for the 13th and 14th years, respectively. In FY 2026 the international student fees will increase on the Main Campus, with fees for undergraduate and Professional Master's international students increasing by \$500 per semester and the fee for international graduate students not enrolled in a Professional Master's program increasing by \$45. In FY 2027 a \$1,000 per semester increase to the engineering, computer science/data science/artificial intelligence and Mitch Daniels School of Business differential fees will be implemented for undergraduate non-resident and international students enrolling for the first time in fall 2026 or after. Indiana residents, graduate students and all students enrolled prior to fall 2026 will not be impacted by the differential fee change.

For the Regional Campuses, it is proposed that tuition and mandatory fees for Indiana residents be frozen the next two years, consistent with the recommendation from the Indiana Commission for Higher Education and Governor Mike Braun. Rates for out-of-state and international students at the Regional campuses are proposed to increase by 3%.

The required public hearing on proposed tuition and fees for all campuses for FY 2026 and FY 2027 is scheduled for June 2. Any feedback shared at the hearing or received in writing will be summarized and presented to the Board prior to formal approval on June 6.
