Item #5 - Guest Speaker

- Brenda Coulson, Senior Director, Talent Acquisition
 - Shared trends around recruiting and candidate experience data
 - Demand for hybrid/remote roles preference varies
 - Transparency and respect are key
 - Internal mobility and upskilling
 - Data-driven recruitment for candidate fit
 - AI & Automation resume screening, outreach and interviewing
 - Focus on transparency, engagement, and creating positive impressions
 - Feedback shapes improvements
 - Top motivations for pursuing a Purdue career are career growth, Purdue's collaborative culture, pride in Purdue's mission, and Purdue's benefits package
 - Interview process satisfaction increased by 12%, noted improvements in transparency and communication during interview stage, and 82% of interviewees would recommend Purdue University
 - Communication from hiring manager dissatisfaction increased by 5%, transparency 22% dissatisfied steps being taken to change this
 - 82% would reapply to Purdue compared to industry average
 - Time to accept offer dropped to 27 days
 - Applicants per hire increased by 42.86%
 - Withdrawal rates decreased by 11.82%
