## 2. **Selected Funding Opportunities:**

**NSF Cyberinfrastructure for Sustained Scientific Innovation (CSSI)** The Cyberinfrastructure for Sustained Scientific Innovation (CSSI) program seeks to enable funding opportunities that are flexible and responsive to the evolving and emerging needs in cyberinfrastructure (CI). The program continues to emphasize integrated CI services, quantitative metrics with targets for delivery and usage of these services, and community creation. The CSSI program anticipates three classes of awards: Elements, Framework Implementations, and Transition to Sustainability. Prospective Principal Investigators (PIs) should be aware that this is a multi-directorate activity and that they are encouraged to submit proposals with broad, interdisciplinary interests. Deadline: December 1

**DOD-CDMRP Alzheimer's Research Program (AZRP)** The AZRP seeks to support transformative research on Alzheimer's Disease/AD-Related Dementias with outcomes relevant to the populations they aim to benefit, including Service Members, Veterans, their Families and the general public. Mechanisms include: Transforming Care Award; Transforming Diagnosis Award; and Transforming Research Award. Deadlines: June 12 – Pre-application; August 29 Application

**DOD-CDMRP Breast Cancer Research Program (BCRP)** The BCRP challenges the scientific community to design research that will address the urgency of ending breast cancer. Specifically, the BCRP seeks to accelerate high-impact research with clinical relevance, encourage innovation and stimulate creativity, and facilitate productive

collaborations. Mechanisms include: Breakthrough Award Levels 1 and 2; Clinical Research Extension Award; Era of Hope Scholar Award; and Breakthrough Award Level 3. Deadlines: June 13 – Pre-application; June 27 - Application

**DOD-CDMRP Ovarian Cancer Research Program (OCRP)** The OCRP establishes priorities to target the most critical needs along the research development pipeline from basic to translational to clinical research, including clinical trials, and to push the field of ovarian cancer forward to our vision to “eliminate ovarian cancer.” Mechanisms include: Pilot Award; Investigator-Initiated Research Award; and Ovarian Cancer Clinical Trial Academy – Early-Career Investigator Award. Deadlines: June 12 – Pre-application; September 11 - Application

**NEH Preservation and Access Education and Training** This program supports projects that develop and implement educational programs for professionals who preserve and provide access to humanities collections. Such materials include but are not limited to moving image and sound recordings, archaeological artifacts, born-digital and digitized collections, rare books and manuscripts, archival records, material culture, and art. Project activities must support one or more of the following programmatic areas: Field services, networks, or consortia that offer training and educational resources and services to professionals; Continuing education opportunities that provide professionals with extended or specialized training in new or current preservation and access topics; or Student and early career programs focused on building skills in preservation and access for cultural heritage collections. Programs may occur at either academic or non-academic institutions. Deadline: May 20

**American Association for Cancer Research AACR Career Development Awards in Lung Cancer Research** The AACR Career Development Awards in Lung Cancer Research have been established to encourage and support early-career investigators to conduct lung cancer research and establish successful careers in this field. The proposed project may be basic, translational, clinical, or population-based research in nature and must have direct applicability and relevance to lung cancer. Each award provides \$250,000 over two years. Eligible faculty must have an independent laboratory space and be within six years of first faculty appointment as of September 1, 2025. Applicants must be active members of AACR. Deadline: May 29

**DeGregorio Family Foundation 2025 Michael F. Price Memorial Grant** The DeGregorio Family Foundation in partnership with the Torrey Coast Foundation is pleased to announce an RFA for up to \$2 million regarding gastroesophageal cancer malignancies. The RFA is for existing or new drug development for an early phase clinical trial or for a late-stage research project ready for IND-enabling studies that may advance our understanding of gastroesophageal cancer and lead us to impacting patient care. Completion date should be between 1 to 3 years. Grants may be supported in full or partially based on the aims of the project, novelty and feasibility. Deadlines: June 16 - LOI; September 5 - Application
