**ANNUAL TRANSITION/KICKOFF MEETING 2024**: This year's meeting/luncheon will again be held at St. Andrew United Methodist Church and catered by Christos and St. Andrew UMC. The meeting will take place on Wednesday, June 5<sup>th</sup>. We will recognize outgoing committee members, new officers and committee members. Committee Chairs and their members will discuss plans for the coming year and each Chair will share an overview of these plans with the group. The "passing of the gavel/key" from current PURA President Tom Robertson to incoming President Marshall Martin will also take place.

## AWARD RECIPIENTS:

Arthur G. Hansen Award: There were no nominees in 2023-24.

Betty M. Nelson Special Recognition Award: Karen Lembcke, former Chair of the Communications Committee, was the recipient for 2023. Karen was actively involved with the Communications Committee for 11 years and was an integral part in preparing the monthly edition of the PURA Newsletter.

**BENEFITS COMMITTEE**: The committee continues to work with University staff and healthcare consultants in offering PURcare and Medicare Advantage Plans to retirees. Both plans remained unchanged for 2024. The premium for Medicare Advantage remained unchanged (\$172.91/mo.) and the premium for PURcare increased slightly from \$290.97 to \$298.39 a month (a 2.5% increase).

Recommendations resulting from an evaluation of the negotiation of the 2024 insurance package (conducted in the Fall of 2023) will be utilized during the negotiation of the 2025 insurance package.

Three members of the Benefits Committee are represented on other University committees: Rick Crosier - Purdue Retirement Plan Committee; Carolyn Roper - University Compensation and Benefits Committee; and Larry Pherson - University Parking and Traffic Committee.

The committee continues to work with the University Parking Office to transition to a License Plate Recognition system scheduled to begin in August 2024.

Pertinent information related to retiree benefits is communicated via various means throughout the year: PURA Website, Purdue employee fair, E-mail, Spring Conference, etc.,

**CAMPUS AND COMMUNITY ACTIVITIES COMMITTEE**: Four events were offered in 2023-2024 and were well attended:

- June 16 a tour of the Whittaker Inn given by Elizabeth Whittaker. Tour participants viewed
  most of the 13 guest rooms which featured a different theme from locations traveled by the
  Whittakers. Lunch prepared in the Inn's kitchen was enjoyed by those attending.
- 2) October 16 a tour of Mackey Arena, the Holloway Gymnasium and Ross Ade Stadium was a big hit for attendees.
- 3) October 30 a tour of the Sonya L. Margerum City Hall in West Lafayette. The former Morton School building is now home to West Lafayette City Offices. The building was extensively renovated in 2019 and 2020.
- 4) May 2 a tour of Dudley and Lambertus Halls the new engineering and technology Gateway Complex near Knoy Hall on campus. Attendees viewed cutting edge laboratories, etc., and were impressed by the quality of these new facilities which are the only ones of their kind anywhere in the country.

**FINANCE COMMITTEE**: The PURA Treasurer tracks and handles all finance, endowments and budget responsibilities. PURA continues to received an allocation of \$17,000 from the Purdue University general fund to be used for organizational expenses. In addition to the \$17,000, there was a carry forward of \$522.23 from 2022-23 fiscal year. Expenses totaled \$14,772.67 through April 2024. A projected carry forward of approximately \$3,700 leaves PURA in good financial shape for the coming year.

Other account balances are all positive. The Activities and Opportunities Endowment Account has a balance of \$67,545.60. The Retirement – Outside Agency Activities has a balance of \$52,332.29. The Purdue Opportunity Award – Martin and Patty Jischke account receives endowment income twice a year to support scholarships for Purdue students. Scholarship payments totaled \$3,500. Balance in this account is \$421.78.

The Finance Report will be updated in August after year-end balances are reported.

**FLU SHOTS**: Flu shots and wellness checks were held at the Daniel Turfgrass Center located on Cherry Lane on September 29; October 6; and October 13. There were 719 flu shots given during the three-day period. The flu shots were administered by the Purdue Center for Healthy Living. There was not a designated drive-through this year for PURA. However, there were four days of drive-throughs (September 27 and 28 and October 4 and 5) for all Purdue employees at the Purdue Center for Healthy Living located at the Purdue West Shopping Center which retirees could take advantage of.

**HOSPITALITY COMMITTEE**: On September 11, 2023, the committee welcomed retirees to the Courtyard by Marriott for the annual Kick-off Luncheon. Committee members also distributed door prizes.

In September and October, the committee assisted the Center for Healthy Living as they offered flu shots and wellness screenings for retirees over a three-day period at the William H. Daniel Turfgrass Center. 719 retirees took advantage of the flu shot event.

On April 17, 2024, committee members greeted and guided retirees and vendors at the Beck Agricultural Center for the annual PURA Spring Conference and distributed the many door prizes supplied by vendors.

Throughout the year, committee members greeted retirees and decorated tables for the monthly meeting at the VFW.

Members were also at Spring Fling on May 23<sup>rd</sup> to answer any questions retirees and those nearing retirement had.

### KICKOFF LUNCHEON COMMITTEE:

The PURA Kickoff Luncheon was held on September 11,, 2023 at The Courtyard by Marriott-Lafayette. The event began at Noon with opening comments followed by lunch. Door prizes were also announced during the luncheon. After lunch, guests were announced and the keynote speaker, Anthony Cawdron, Westwood Event Coordinator and Estate Manager, gave an entertaining talk titled "Keeping House – From Blenheim to Westwood". Anthony is also an adjunct professor in the Hospitality and Tourism Management Department at Purdue. Following Anthony's talk, the Betty M. Nelson Award was presented to Karen Lembcke for her many years of service to the Communications Committee.

Luncheon reservations totaled 130. The registration fee was increased from \$18 to \$25 in 2023. The fee increase helped offset an increase in food costs and using the Purdue Hall of Music staff for audio visual support. The PURA Executive Board agreed to cover expenses above the registration fee income.

**MEDIA COMMUNICATIONS**: The major effort of the committee this year was to assist in the transition from a monthly Newsletter to specific purpose e-mails. The retiree e-mail database is maintained by Purdue for Life but keeping the database current with accurate retiree contact information continued to be challenging. Additionally, the database does not contain complete information of retiree spouses who are also full members of PURA. An effort to address this with Purdue HR will be a priority for 2024-2025.

The committee continued maintenance of the PURA website. The website was also restructured to focus on current information on the landing page. PURA archives and historical information continues to be available on the website.

The committee supported many Zoom meetings for monthly meetings, and Benefits Committee meetings. Executive Board meetings moved to Microsoft Teams because of facilities available at the 2550 building.

The committee also manages e-mail sent to PURA@purdue.edu and gets it routed for responses.

**PROGRAM COMMITTEE:** For 2023-2024, committee members asked to change the monthly meeting time from a lunch to 10:00 a.m. The PURA Executive Board approved and agreed to pay for refreshments. Attendance has picked up a bit and with those attending via Zoom the numbers are about

the same as when everyone was attending via Zoom during the pandemic. Although in-person attendance is not what it was before the pandemic, progress is being made with the new time.

Program speakers and topics continue to be excellent and well received. Program recordings are archived and available to be viewed at later dates.

PURA ANNUAL SPRING CONFERENCE: This year's Spring Conference was held on April 17<sup>th</sup> at the Beck Agricultural Center with more than 200 attendees and 29 vendors. Once again, the event was catered by Christos beginning with coffee and pastries, etc., in the morning and a delicious hot meal for lunch. The program began with Lisa Duncan, Purdue's Nonprofit Engagement Director, outlining a printed document listing Volunteer Options for Seniors in the Lafayette area. Following was Garry Gumasing, Director of Therapy at St. Anthony's Rehabilitation Center speaking on Understanding Dementia/Stroke/ALS Disorders and Rehabilitation. Other speakers/topics were: Tommy Kleckner, Western Indiana Regional Director for Indiana Landmarks – "Day Trips for Seniors"; Amy Boyle, PURA Liaison and Purdue Vice-President for Human Resources gave an update; Paul Bercot Sr., Purdue Research Foundation and Amber Chellis-Omedo, Sr. Director, Purdue Campus Planning & Architecture – "Campus/Area Improvements and Future Plans for New Facilities" and the afternoon event was highlighted by Dr. James Mohler, Executive VP for Research, Partnerships and Scientific Integrity – "Artificial Intelligence and it's Potential Impact on Seniors".

Throughout the program, a variety of great door prizes were announced.

**PURA WEBSITE**: <a href="www.purdue.edu/retirees">www.purdue.edu/retirees</a> As mentioned in the Annual Report of the Media Communications Committee, the website was restructured to focus on current information on the landing page. PURA archives and historical information continues to be available on the website.

**RETIREE GIVING TO THE UNITED WAY OF GREATER LAFAYETTE:** Purdue retirees continue to generously support the community. For the 11<sup>th</sup> consecutive year, they contributed significantly to the annual campaign surpassing their goal of \$181,000.

**SCHOLARSHIP COMMITTEE**: Awards in excess of \$16,000 were distributed from PURA scholarship endowments for the 2023-2024 academic year. \$12,910 was awarded to the 5 PURA Student Scholarship Endowment recipients and \$4,000 was awarded to the 3 PURA POA Jischke recipients. These funds are a portion of a complete financial aid package offered to Indiana students. Student selection and award amounts are administered by the Division of Financial Aid. The Book Value of the PURA Student Scholarship Endowment as of April 30, 2024 is \$259,164, an increase of \$12,302 from the same time last year. The Book Value of the PURA POA in Honor of Martin C. and Patty Jischke is \$61,074, an increase of \$2,625 from the same time last year. The Market Value of the PURA Student Scholarship Endowment is \$302,803 and the Market Value of the PURA POA in Honor of Martin C. and Patty Jischke is \$72,932. The current Book Value totals do not reflect the Purdue Day of Giving April 24, 2024, donations as they will not be communicated from University Development until July 2024.

Thirty-six donors made contributions to the PURA Student Scholarship Endowment. Seven of those were new donors. Seven individuals contributed to the PURA POA in Honor of Martin C. and Patty Jischke Endowment.

The April 24, 2024, Purdue Day of Giving leaderboard showed an increase to the PURA scholarship Endowments of \$6,180 -- \$5,580 for the PURA Student Scholarship Endowment and \$600 for the PURA

POA in Honor of Martin C. and Patty Jischke Endowment.

## **OVERALL:**

This past year continued to be a year of excellent offerings and opportunities. We all want to keep connected and to continue to develop relationships and offerings for our retirees. The annual reports written by our officers and committee chairs share even more about all that occurred. ## B. Mission/Purpose:

Purdue University Policy IV.3.1, Status and Privileges of Retired Faculty and Surviving Spouses and Children, originally issued on May 10, 1971, and revised December 12, 2001 outlines the specific benefits extended by the University. It is the purpose of the Benefits Committee to expand upon and add to the specific University policies which contribute to the wellbeing of retirees. The primary responsibilities of the Benefits Committee are to assure the provision of comprehensive, affordable medical plans for retirees, negotiate with insurance providers, evaluate changes, monitor services and investigate alternatives where advantages may be gained. The committee strives to keep retirees aware of additional University benefits and privileges and promotes program improvements where possible. The Benefits Committee is also responsible for assuring representation on the Purdue Faculty Compensation and Benefits Committee, Parking and Traffic Committee and the Retirement Plan Committee.

- C. Committee Goals 2022-2023:
- 1) Finalize with UHC by August 31, 2023, the PURCare and PURA Medicare Advantage Plans for 2024.
- 2 Announce PURCare and Medicare Advantage Plans for 2024 to PURA membership via the PURA Newsletter and letter by September 2023.
- 3) Evaluate the renewal process for the 2024 plan and identify potential improvements by October 31, 2024.
- 4) Set Schedule for negotiating 2025 PURA plans by March 31, 2024.
- 5) Enhance the diversity of the Committee so that the Committee may better serve all current and future Purdue retirees.
- 6) Continue participation in the activities of the Parking and Traffic Committee, the Retirement Plan Committee and the Faculty Compensation Committee.
- 7) Actively engage in the Annual Spring Conference and the Road to Retirement Programs.
- 8) Obtain adequate clerical support for the activities of the Benefits Committee
- 9)Continue to monitor actions of external organizations (state and federal governments and organizations involved in the delivery of healthcare services and products) to assess the possible impact of these actions for PURA's members.

- 10) Develop a succession plan for the leadership of the Benefits Committee.
- 11) Review and update as necessary the Benefits Committee portion of the PURA website.
- 12) Coordinate with the University Parking Office the continuation of free on-campus parking for University retirees.
- D) Accomplishments 2023-2024
- 1)Working with University staff and healthcare consultants, PURcare and the Medicare Advantage Plans were extended for 2024. Both plans remained unchanged. The premium for Medicare Advantage, which is \$172.91 per month, was unchanged. The monthly premium for PURcare increased to \$298.39, an increase of 2.5%.
- 2)An evaluation of the negotiation of the 2024 insurance package was conducted during the Fall of 2023. Recommendations resulting from that evaluation will be utilized during the negotiation of the 2025 insurance package.
- 3)During 2023-24, Rick Cosier was the PURA representative to the Purdue Retirement Plan Committee; Carolyn Roper was the representative to the University Compensation and Benefits Committee and Larry Pherson was the representative to the University Parking and Traffic Committee.
- 4) The following are examples of the Committee's communication and marketing efforts:
- a) Prepared articles for the PURA Newsletter, including the announcement of United Healthcare's new drug plan's ID cards that were effective January 1, 2024.
  - b) PURA Spring Conference.
- 5)The Benefits Committee portion of the PURA website was continually monitored and updated.
- 6) The document listing the benefits that are available to Purdue University retirees was continuously monitored, updated and posted to the PURA website.
- 7) The schedule for negotiating the 2025 plans has been proposed to and accepted by UnitedHealthcare.
- 8) Assisted in staffing the PURA table at the Purdue Employees Benefits Fair.
- 9)The Committee with assistance from its consultant, Aon, began research to better the implications of the Inflation Reduction Act of 2022 for the upcoming renewal of PURA medical plans.
- 10) Three new members were added to the Committee during 2023-24.
- 11) Coordinated with the University Parking Office, the transition to a License Plate Recognition system which will be utilized for retiree parking effective August ,2024.
- 12) Continued monitoring governmental activity relating to Affordable Healthcare, Tax Code revisions and the Inflation Reduction Act.

13) The Committee considered adding an additional zero premium Medicare Advantage plan. After much review and discussion, it was determined that a significant advantage beyond that available in the open market could not be provided.
All in all, the Benefits Committee had a successful 2023-2024 and was quite busy.

## Campus and Community Activities Committee Annual Report 2023-2024

The goal of the Campus and Community Activities (CCA) Committee is to offer educational, informative, and entertaining activities of interest to members of the Purdue University Retirees Association and their guests. Generally, committee activities do not require chartered transportation or collection of registration fees. Reservations are accepted to assure that adequate space and/or seating is available. Limitations on the number of reservations accepted are determined by the activity and venue. Announcements of events are placed in the PURA newsletter, through e-mail, and/or announced at the monthly PURA meetings.

Four campus and community tours were offered during the 2023-2024 academic year. The year's activities were as follows.

## Summer 2023

On June 16<sup>th</sup>, Elizabeth Whittaker gave a tour of the Whittaker Inn to 19 PURA members. The tour presented the history of the facility as well as plans for future expansion. Attendees were able to see most of the 13 guest rooms in the facility, with each room featuring a different theme from locations special to the Whittakers. The tour was capped off with delicious lunch from the inn's own kitchen.

## Fall 2023

On October 16<sup>th</sup>, Al Capitos, Associate Athletics Director for Facilities and Event Management, led 20 Purdue retirees on a tour of Mackey Arena, the Holloway Gymnasium, and Ross Ade Stadium. Al provided insights into past, current, and future projects for athletic facilities. The tour was a big hit with those who were able to attend, and we hope to have a similar tour in the future for those who wanted to see the facilities but were unable to join this tour.

On October 30<sup>th</sup>, Jen Van Schuyver, Deputy Director of Development for the City of West Lafayette, led a group of 24 retirees on a tour of Sonya L. Margerum City Hall. Jen described how the former Morton School building was renovated in 2019 and 2020 to become the new home of West Lafayette's city offices. Attendees were able to tour throughout the building including city council chambers, conference and meeting rooms, employee workspaces, community use spaces, and even the mayor's office. Everyone was impressed with the building which provides an excellent space for city offices with room to grow in the future!

## Spring 2024

On May 2, Ernie Avellana - Chief Development Officer for the Purdue Polytechnic, Tim Updike - Operations Manager, and others hosted 15 PURA members on a tour of Dudley and Lambertus Halls, the new engineering and technology Gateway Complex near Knoy Hall on campus. Attendees were able to see cutting-edge laboratories and maker spaces for smart manufacturing, electronics, construction, and

more. Those who were able to attend were impressed by the quality of these new facilities, which are the only ones of their kind anywhere in the country. The new building supports classes from engineering and technology and will help to anchor a new manufacturing major being offered by the Polytechnic.

## 2023-24 Annual Financial Report

PURA continues to receive an allocation of \$17,000 from the Purdue University general fund to be used for organizational expenses such as publication of the newsletter, supplies, travel, committee and program activities as well as the kickoff luncheon. There was a carry forward in this account from the 2022-23 fiscal year of \$522.23.

Expenses totaled \$15,522.67 for the year. The largest categories were the transition luncheon (\$2,376.57), the Big 10 Conference travel (\$2052.17) and increases in printing and postage costs (3,806.87). A projected carry forward of \$2,429.40, leaves the Purdue Retiree Association in good financial shape for the start of the coming fiscal year.

Other account balances are all positive.

Other accounts holding funds for PURA are the Activities and Opportunities Endowment Account, Retirement Activities — Outside Agency Fund and the Jischke scholarship endowment.

- 1. The Activities and Opportunities Endowment Account supports unique miscellaneous expenses not considered operational in nature. This account receives endowment income twice a year. The endowment income for 2023-2024 was \$6,966.27. Expenses charged to this account were \$8,517.74, the bulk of these expenses was \$6595.32 for the catering costs associated with the Annual Spring Conference. The balance in this account is \$63,701.40.
- 2. The Retirement Outside Agency Activities is used to support awards and the committee members retiree gift to the University Scholarship account. Expenses charged to this account were for retiring committee members of \$625 and \$250 for a conference honorarium. Income from sponsors for the Annual Spring Conference totaling \$8,425 was deposited into this account to offset expenses not charged to the University Conference Division account. The balance in this account is \$54,832.29.
- 3. Purdue Opportunity Award Martin and Patty Jischke account receives endowment income twice a year to support scholarships for Purdue students. The endowment income was \$2,516.92. The scholarships payments totaled \$3,500. The balance in this account is \$445.74.

**Primary Goal:** The primary goal of this committee is to continue growing the PURA scholarship endowments to provide funds to assist as many Indiana students with significant financial need as possible. Committee members will fundraise for and mentor students for the two endowments: PURA Student Scholarship Endowment and the PURA Purdue Opportunity Award (POA) in Honor of Martin C. and Patty Jischke.

**Scholarships Awarded:** Awards in excess of \$16,000 were distributed from PURA scholarship endowments for the 2023-2024 academic year. \$12,910 was awarded to the 5 PURA Student Scholarship Endowment recipients and \$4,000 was awarded to the 3 PURA POA Jischke recipients. These funds are a portion of a complete financial aid package offered to Indiana students. Student selection and award amounts are administered by the Division of Financial Aid.

Communication with Students: The Scholarship Committee Chair requests the following information from the University Development Office: student name, degree area, hometown in Indiana, address, email address and cell phone number (sometimes these are not available) and photograph of the student. The University Development Office routinely asks the students for letters of appreciation or thank you letters. Those are forwarded to the Scholarship Committee Chair. A welcoming email is sent to all of the students inviting them to participate in the monthly educational activity.

**Scholarship Balance:** The Book Value of the PURA Student Scholarship Endowment as of April 30, 2024 is \$259,164, an increase of \$12,302 from the same time last year. The Book Value of the PURA POA in Honor of Martin C. and Patty Jischke is \$61,074, an increase of \$2,625 from the same time last year. The Market Value of the PURA Student Scholarship Endowment is \$302,803 and the Market Value of the PURA POA in Honor of Martin C. and Patty Jischke is \$72,932.

The current Book Value totals do not reflect the Purdue Day of Giving April 24, 2024, donations as they will not be communicated from University Development until July 2024.

**Donors and Gifts:** Thirty-six donors made contributions to the PURA Student Scholarship Endowment. Seven of those were new donors. Seven individuals contributed to the PURA POA in Honor of Martin C. and Patty Jischke Endowment.

The April 24, 2024, Purdue Day of Giving leaderboard showed an increase to the PURA scholarship endowments of \$6,180 -- \$5,580 for the PURA Student Scholarship Endowment and \$600 for the PURA POA in Honor of Martin C. and Patty Jischke Endowment.
